

Requirements to Travel to Israel and Waiver of Liability for COVID-19

Dear traveler/s:

It is with great Joy that we are finally able to resume our tours to Israel.

We take great pride with the opportunity given to us to facilitate this great journey and we would like you to know that we will do everything in our power to make this tour as safe and as memorable as possible.

When traveling to Israel:

- **A health insurance policy with coverage for the treatment of COVID-19 is required.**
The insurance policy is a mandatory to enter Israel.
- **All passengers must check with their airline(s) to see what, if any, Covid tests must be taken and what protocols must be followed to board their flight(s)**

The safety of our travelers has always been on our top priority. However, there is no way to eliminate all possible risks while traveling and therefore cannot assume liability in the unlikely event you contract COVID-19. This is the reason for the necessity of the following waiver of liability:

By signing below, you assume all risks in the unlikely event you are exposed to, or infected by, COVID-19. The novel coronavirus, Covid-19, (herein "COVID-19) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments have recommended physical distancing, limiting group sizes in some locations and wearing face coverings.

America Israel Tours has put in place preventative measures to reduce the spread of COVID-19. However, America Israel Tours cannot guarantee that you or your travel party will not become infected with Covid-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participating in the America Israel Tours trip and that such infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming infected by COVID-19 on a America Israel Tours trip may result from the actions, omissions, or negligence of myself and others, including, but not limited to travel suppliers' employees, suppliers and other passengers. I agree that having considered these risks, I desire to participate in this tour and I freely and voluntarily assume complete personal responsibility for the risk of exposure, illness and death due to COVID-19, even if such injuries or death occur in a manner that is not foreseeable at the time this agreement is signed.

I HAVE READ AND UNDERSTAND THE COVID GUIDELINES FOR ENTRY AND DEPARTURE AND THE WAIVER OF LIABILITY I FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

I agree that if any portion is found to be void or unenforceable, the remaining portions shall remain in full force and effect. No additions, deletions or changes can be made to the release form, and signing it is a requirement for joining the trip.
